

## Gifts in Action

Philanthropy has changed the landscape of St. Michaels University School and enriched the everyday student experience throughout our history. From new facilities to financial aid and programming inside and outside of the classrooms, our students benefit immensely from the foresight and generosity of planned gifts.

Some examples of this impact include:

#### Financial Aid

SMUS provides approximately \$1.7 million in financial aid every year thanks in part to the support of planned gifts received and endowment fund earnings. With 20% of our student population benefiting from this generosity, we are able to remove financial barriers to attending the school for many.

#### Program Facilities

From the squash courts to our classrooms, purpose-built spaces on our campuses bring the innovative ideas and teaching of our faculty to life to enhance the student experience. Our facilities are the foundation of solid sports coaching, lively arts curricula and leading academic programs.

#### Sun Centre

Officially opened in 2018, the Sun Centre has become a social hub for our Middle and Senior School students who come together to share their meals and their downtime here. The bright and warm space is the perfect backdrop for the nutritious meals that fuel our students' days.



# How to Make a Planned Gift

After you have provided for your family and those you love in your will, please also consider naming St. Michaels University School as a beneficiary. This is an extraordinarily meaningful way to leave a legacy.

There are many kinds of planned gifts including, but not limited to, simple bequests in a will or trust, gifts in kind and gifts of RRSPs, TFSAs and insurance. As planned gifts may make use of legal and tax strategies, we recommend you speak with a lawyer, financial advisor and/or tax professional to discover which option is best suited to your unique needs.

#### **Bequests**

A bequest is a gift made through a will or living trust. It is usually a set dollar amount or percentage of an estate that goes to a charitable organization after a donor's passing. To include a bequest in your will, you will need to give the legal professional drafting your will our legal name, address and charitable business number. It is essential that this is correct:

#### Gift of Securities

A gift of securities is a gift that can include publicly traded stocks, bonds and mutual funds. There may be tax advantages to you if you are considering this gift vehicle, either during your lifetime or after. You are best served if you contact SMUS before making such a gift. You may also include securities in a bequest.

#### Other Means of Giving

There are other vehicles that could be considered in your estate planning that may have beneficial tax advantages for donors. Again, we recommend in all cases that you discuss your financial decisions with your own lawyer, financial advisor and/or tax professional.



#### Community for Life

Nick Etheridge '61 attended St. Michael's School through the generosity of others. A bursary removed the financial barrier to attending, and inside the school he found a community for life.

He graduated from University School after completing his primary years at St. Michael's School. He credits the schools with helping him discover his academic interests, a focus that would go on to inform his 35-year career with Global Affairs Canada. Through learning and life, Nick remains committed to the value of community and citizenship.

"Whether you are a 'capital L' leader or not, you can contribute to community and that is the most important thing," he says.

It is for this reason he is choosing to support the school through a planned gift.

"Community is extremely important. That is something the school can impart, and it did when I was there. I have a sense of belonging. I am supporting SMUS through my estate to pay forward the opportunity I was given."
